- You will be presenting your research alongside 5 other presenters. The time is <u>strictly 8</u>
 <u>minutes</u> per presentation.
- You can complement your presentation with slides. Presentations should be preferably
 prepared in PowerPoint, but other formats can be accommodated. EHMA will provide you
 with an EHMA 2025 branded template. You are welcome to add your organisation's logo and
 personalise it at your convenience, or you can use your own slide deck.
- To ensure the smooth running of your session, we ask you to **send your presentation by Wednesday**, **14 May 2025** to <u>conference@ehma.org</u>. If you need more time, please let us know. If you make substantial changes in your presentation from the version you sent to us, please notify us via email or, <u>as last resource only</u>, on the spot at the registration desk.
- On the days of the conference, please have your presentation available on a USB pen and accessible without WiFi.
- We advise you to ensure that graphics, written or tabular material must be of adequate size to be clearly visible.
- A Q&A session will take place at the end of the session after all presentations have been
 delivered. We will put you in touch with the moderator of your session to discuss the order
 of the presentations and the questions that will be raised during the Q&A session.
- The best paper will be announced and awarded the €1.000 prize during the Closing ceremony on Friday, 6 June from 16.45 to 17.30.
